NOTIFICATION

The 20th October, 2012

No. FTX.58/2008/254: In exercise of the powers conferred by sub-section (3) of section 6 of the Assam Entry Tax Act, 2008 (Assam Act XII of 2008), the Governor of Assam, having considered it necessary in the public interest so to do, hereby exempts the importer shown in column (1) of the Table below from the liability to pay entry tax in respect of specified goods mentioned in column (2) when imported into local area for use, subject to the restrictions and conditions specified in column (3) of the said table:-

Brahmaputra Cracker and Polymer Limited	(1) Air-conditioning plant (2) Fire-tenders, cranes, forklift trucks and trolleys (3) Computer of all varieties, computer software and hardwares, servers, V-sat and accessories including UPS used with computers. (4) All types of plant and machineries including parts and accessories thereof (5) Pump sets of any type (6) Diesel generators (7) Elevators and parts and accessories thereof (8) Aluminium conductors of any kind (9) M.S Pipes (10) Chemicals (11) Pipes of all kinds (12) Transformers (13) Railway track materials such as all types of pre-stressed concrete sleepers, railway switches, crossings, fittings, SGLI inserts, HTS wire, metal liners, bolts, nuts and elastic rail clips (14) Transmission tower (Electrical and Telecommunication) and tower parts (15) Optical fibre cable (16) Aluminium composite panel (17) Electrical goods of all types	(i)The goods are imported exclusively for use in the industrial plant per se. (ii)Such specified goods shall be used in the Gas Cracker Plant only and shall not be used in associated facilities of the Plant like schools, club, administrative building, hospital, residential quarters etc. (iii)The Unit shall submit a report on use of goods imported within one month.

This notification shall be deemed to have come into force on 20th October, 2009 and this supercedes earlier Notification No. FTX.58/2008/71 dated 20th October, 2009 published in the Assam Gazette No. 332 dated 20th October, 2009.
