No. CTS-1/2009/Pt/43:- In exercise of the powers conferred by sub-section (9) of Section 3 of the Assam Value Added Tax Act, 2003 (Assam Act VIII of 2005) and in super-session of earlier notifications No. CTS-2/2005/170 dated 28th April, 2005, No. CTS-45/95/Pt/2004/23 dated 17th August, 2007 and No. CTS-45/95/Pt/2004/27 dated 19th November, 2007 except as respects things done or omitted to be done before such super-session, it is hereby notified for the purpose of this Act, the powers of the Prescribed Authority under section 36 and 37 and powers of Commissioner of Taxes under sections 55, 73, 74, 75, 78, 82(1), 89, 90, 95 and 96 of the Act are delegated with effect from 19th May, 2009 to the Taxing Authorities mentioned in column (2) of the Schedule below.
