NOTIFICATION

The 11th November, 2006

No. FTX.55/2005/Pt/65:- In exercise of the powers conferred by sub-section (3) of section 20 of the Assam Value Added Tax Act, 2003, the Governor of Assam is hereby pleased to make the following amendment to the notification published in the Assam Gazette Extraordinary dated 29.04.2005, namely:-

In the Government notification No. FTX.55/05/Pt/31 dated 29.04.2005 published in the Assam Gazette Extraordinary dated 29.04.2005,

- (i) in the first paragraph, for the words, figures and punctuation marks, "an amount at the rate of Rs.31,000/- (Rupees thirty one thousand) in respect of each truck load of marble imported by him from outside the state subject to the following conditions:-", the following words, figures and punctuation marks shall be substituted, namely:—

"an amount of Rs.31,000/- in case of a six wheeler truck;
an amount of Rs. 50,000/- in case of a ten wheeler truck;
an amount of Rs.1,00,000/- in case of a trailer truck,
an amount of Rs.1,500/- per tonne in case of consignment imported otherwise as above in respect of marble imported by him from outside the State subject to the following condition:-";

- (ii) in the sixth para, at the end, the following words shall be inserted, namely:-

"The dealer shall submit a monthly statement as per format given as annexure-III";

- (iii) the following format shall be inserted at the end of the notification as Annexure-III, namely:-
