#### GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR FINANCE (TAXATION) DEPARTMENT

#### **NOTIFICATION**

The 3rd November, 2009

No. FTX.66/2009/2: In exercise of powers conferred by sub-section (1) of section 54 of the Assam Value Added Tax Act, 2003 (Assam Act VIII of 2005) (hereinafter referred to as the Act) and sub-section (5) of section 8 of the Central Sales Tax Act, 1956 (Central Act 74 of 1956), the Governor of Assam is hereby pleased to notify the Assam Industries (Tax Exemption) Scheme, 2009, hereinafter referred to as the Scheme, for granting exemption partially to such units, which manufacture goods in Assam in the manner hereinafter appearing, namely:-

#### 1. Short title and commencement.—

- (1) This Scheme may be called the Assam Industries (Tax Exemption) Scheme, 2009.
- (2) The Scheme shall be deemed to have come into force with effect from 1<sup>st</sup> October, 2008. The benefits given under the Scheme shall be available till the Assam Value Added Tax Act, 2003 remains in force.
- (3) The Scheme shall apply to the units, which manufacture goods in Assam which are considered eligible for partial tax exemption with reference to the Industrial and Investment Policy of Assam, 2008 hereinafter to be mentioned as Industrial Policy, 2008.

#### PART-I

#### 2. Definition of Eligibility.—

Following shall be the eligible units for the purpose of this Scheme:-

Category "A":- A new unit, which manufactures goods in Assam and has commenced commercial production on or after 1<sup>st</sup> October, 2008 but upto 30<sup>th</sup> September, 2013 and is in compliance with the eligibility criteria under this Scheme shall be treated as an unit eligible for benefit under this Scheme under category "A".

In case, a new unit is promoted in the premises of an existing unit it should be distinctly identifiable and be located in the open spaces available in the premises. The earlier unit in the premise should not be closed nor any plant and machinery be dislodged from the earlier unit.

Category "B":- An existing unit, which manufactures goods in Assam, which undertakes substantial expansion and such substantial expansion is completed and commercial production after such substantial expansion commences on or after 1<sup>st</sup> October, 2008 but upto 30<sup>th</sup> September, 2013 and is in compliance with the eligibility criteria under this Scheme shall be treated as an eligible unit under category "B".

"Substantial Expansion" means increase in value of fixed capital investment in plant and machinery of an existing unit by at least 25% as well as increase of employment by at least 10% and at least 25% increase in production compared to average annual production of previous 3 years. Prior to going for expansion, the unit should be operating at least at a minimum of 80% capacity during the period of 3 previous years and prior intimation to the concerned implementing agency.

**Category "C":-** An existing unit, which manufactures goods in Assam and has been declared sick by BIFR or as Assam Government Relief Undertaking and has recommenced commercial production on or after 1<sup>st</sup> October, 2008 but upto 30<sup>th</sup> September, 2013 and is in compliance with the eligibility criteria under this Scheme shall be treated as an eligible unit under category "C":

Provided that there should be increase by not less than 25% in the value of fixed capital assets in plant and machinery for revival of a unit under category "C".

Provided further that any unit of the categories "A", "B" and "C" shall have to fulfill eligibility criteria given below:-

- (a) A unit shall have employment of 80% from amongst people of Assam in the managerial cadre and 90% from amongst people of Assam in the non-managerial cadre and that over a period of five years from the commencement of commercial production, such unit would take all effective steps to ensure 100% employment from amongst people of Assam in non-managerial cadre and at least 90% in managerial cadre.
- (b) A unit availing grants/incentives from a Department/an agency under the State/Central Government/Foreign agencies shall not be eligible for similar type of incentive under this Scheme.
- (c) The units engaged in manufacture of following categories of goods shall not be eligible for any benefit under this Scheme:-
  - 1. All goods falling under Chapter 24 of the First Schedule to the Central Excise Tariff Act, 1985 (5 of 1986) which pertains to tobacco and manufactured tobacco substitutes.
  - 2. Pan Masala as covered under Chapter 21 of the First Schedule to the Central Excise Tariff Act, 1985 (5 of 1986).

- 3. Plastic carry bags of less than 20 microns as specified by Ministry of Environment and Forests Notification No. S.O. 705(E) dated 02.09.1999 and S.O. 698(E) dated 17.06.2003.
- 4. Goods falling under Chapter 27 of the First Schedule to the Central Excise Tariff Act, 1985 (5 of 1986) produced by petroleum or gas refineries.
- 5. Benefits under this Policy will not be admissible to goods in respect of which only peripheral activities like preservation during storage, cleaning operation, packing, re-packing, labeling or re-labeling, sorting, alteration of retail sale price takes place.

#### 3. Limits of Tax exemption for the eligible units:-

- (1) Where, an eligible unit registered under the Assam Value Added Tax Act, 2003 (Assam Act VIII of 2005) and has received Certificate of Entitlement under this Scheme manufactures any goods in Assam, other than those declared above as not eligible, ninety nine percent of the tax payable by such unit according to its return in respect of sales of such goods manufactured in such unit shall be entitled for partial exemption until the amount of such tax payable exceeds the quantum of monetary ceiling or the period of entitlement, whichever is earlier.
- (2) Subject to the provisions of sub-para (1), all new units (Category 'A'), existing units undergoing substantial expansion (Category 'B') and sick/relief undertaking units (Category 'C') shall be entitled to the benefit of partial exemption of tax on sales of finished products as per following scale:

- (3) Tax payable during the return period by an eligible unit shall be calculated according to the following formula:-
  - (a) Tax payable = Output Tax plus actual or notional tax liability under the Central Sales Tax Act, 1956 (Central Act 74 of 1956) minus Input Tax:

Provided that in a case where the unit is engaged in manufacture of goods taxable at the first point of sale in the Fourth Schedule of the Act, the amount of tax payable during the return period shall be the tax liability on intra-state sale and sales in course of inter-state trade or commerce:

- (b) The amount of tax available for partial exemption to an eligible unit possessing valid certificate of entitlement shall be ninety nine percent of the amount of tax payable in accordance with tax return and the balance one percent of the tax payable shall be deposited into the Government Account. It is, however, made clear that the eligible unit shall be eligible to charge the tax amount in the tax invoice/bill/cash memorandum issued.
- (c) Notwithstanding anything contained in this Scheme, an eligible unit engaged in manufacture of goods taxable at the first point of sale in the Fourth Scheme of the Act, shall not be entitled for availment of any input tax credit (ITC) while computing the amount of "Tax Payable" by it for any return period under the Act.

#### **Explanation:-**

- (a) Micro/Small/Medium/Large Scale Unit: As defined in Micro, Small and Medium Enterprises Development Act, 2006 as amended from time to time.
- (b) Fixed capital means and includes investment in plant and machinery or additional investment in plant and machinery (for expansion unit) and building connected directly with manufacturing process.

In case of micro industries the cost of land purchased upto 40% of total investment in plant and machinery can be included as part of fixed capital investment.

#### 4. Procedure for grant of Eligibility Certificate for category-"A", "B" and "C":-

- (1) An eligible unit falling under Category "A", "B" and "C" shall make an application in the format annexed at Annexure-I, Annexure-II and Annexure-III respectively in this Scheme for issuance of Eligibility Certificate to the specified authority viz., District Level Committee, State Level Committee or the Assam Industrial Development Corporation (AIDC) Committee. Such application shall be supported by all the required documents.
- (2) An application for the Eligibility Certificate shall be verified and signed in the case of—
  - (a) individuals, by the proprietor of the unit;
  - (b) an association of persons, by an adult member or the principal officer;
  - (c) a firm, by the managing partner or an adult partner of the partnership firm;

- (d) a Hindu undivided or joint family, by the Karta, any adult member of the family or the manager;
- (e) a company, by the Managing Director, Secretary or the Chief Executive of the company;
- (f) any Government Department, by the Head of the Office concerned.
- (3) The person making an application shall specify the capacity, in which the application is made, verified and signed.
- (4) (a) In case of micro units, the application for eligibility shall be considered by the District Level Committee.
  - (b) In case of small scale units, the application for eligibility shall be considered by the State Level Committee.
  - (c) In case of medium and large scale units, the application for eligibility shall be considered by the Assam Industrial Development Corporation (AIDC) Committee.
  - (d) In considering the cases, the District Level Committees, State Level Committee and the AIDC Committee, as the case may be shall satisfy themselves, whether all the required conditions and norms have been fulfilled by the unit for being declared as an eligible unit for the purpose of this Scheme.
  - (e) While considering a case, these Committees shall make inquiries for the verification of all information and particulars in each case.
  - (f) In case a unit fulfils all the conditions and norms for being declared as an eligible unit for the purpose of this Scheme, the concerned Committee shall recommend for the grant of Eligibility Certificate in favour of the unit for the purpose of this Scheme.
  - (g) The Eligibility Certificate shall be granted in the format annexed at Annexure-IV, V and VI in this Scheme to the eligible unit of category "A", "B" and "C" respectively by the competent authority.
- (5) (a) Such Eligibility Certificate shall be granted by the General Manager, District Industries and Commerce Centre of the district concerned, on approval of the District Level Committee, if it is the case of an eligible micro unit.
  - (b) Such Eligibility Certificate shall be granted by the Director of Industries, Government of Assam, on approval of the State Level Committee, if it is the case of an eligible small scale unit.
  - (c) Such Eligibility Certificate shall be granted by the Managing Director, Assam Industrial Development Corporation Ltd., on approval of AIDC Committee, if it is a case of an eligible medium/large scale unit.
- (6) (a) Subject to the conditions laid down in para 3 of this Scheme, the Eligibility Certificate issued under the Scheme shall be for a period of 7(seven) years from

the date of commencement of commercial production of an eligible unit of the category 'A' or 7(seven) years from the date of commencement of commercial production after the substantial expansion by an eligible unit of the category 'B' and 3(three) years from the date of commencement of commercial production after rehabilitation by an eligible unit of the category 'C'. This period of 7(seven) years or 3(three) years, as the case may be, shall stand reduced upto the date when the unit reaches the maximum permissible limit of exemption as per para 3 or upto the date of closure of the eligible unit of the categories 'A', 'B' and 'C', if the date of closure, if any, occurs prior to the expiry of the above mentioned period of 7(seven) years or 3(three) years, as the case may be.

(b) If an unit to which an Eligibility Certificate has been granted under this Scheme closes down or reaches the maximum limit of exemption, it shall be the duty of the unit to report within 14 days from the date of such closure in writing to the jurisdictional Assistant Commissioner of Taxes/Superintendent of Taxes and the authority, which had issued the eligibility Certificate to it. Simultaneously alongwith this report, it shall also surrender the original Eligibility Certificate to the authority, which had issued the same and it shall also surrender the Certificate of Entitlement to the concerned Assistant Commissioner of Taxes/Superintendent of Taxes. For any lapse or violation on the part of the unit, it shall be liable for all penal actions under the provisions of the Assam Value Added Tax Act, 2003 and other laws in force.

#### 5. Issue of Certificate of Entitlement:-

- (i) The application for the grant of Certificate of Entitlement by category "A", "B" and "C" shall be submitted in the format at Annexure-VII annexed herewith to the Commissioner of Taxes in case of small/medium/large unit and to the concerned Assistant Commissioner of Taxes/Superintendent of Taxes of a micro unit. It shall be verified and signed in the same way as in the case of application for the grant of Eligibility Certificate vide para 4(2) of the Scheme.
- On receipt of the application for the grant of Certificate of Entitlement from (ii) the eligible unit holding an Eligibility Certificate granted under this Scheme by a competent authority, in the case of micro enterprise, the concerned Assistant Commissioner of Taxes/Superintendent of Taxes having jurisdiction over the unit and in case of small/medium/large unit, the Commissioner of Taxes himself or through officer subordinate to him shall examine as to the correctness of the particulars furnished in the application and the documents accompanying therewith and after making necessary checks, if the Commissioner of Taxes or the concerned Assistant Commissioner of Taxes/Superintendent of Taxes, as the case may be, is satisfied that information furnished in the application is based on the information contained in the Eligibility Certificate granted to the unit concerned and any further information furnished in the application or in connection with it is correct, he shall grant a Certificate of Entitlement to the eligible unit. The Certificate of Entitlement shall be effective from the date of commencement of commercial production in case of category "A" and from the date of commencement of commercial production after substantial expansion in respect of the eligible units falling under category 'B' and from the date of commencement of commercial production after rehabilitation in respect of the eligible units

falling under category 'C' and it shall be valid for a financial year. Such Certificate of Entitlement shall be granted in the format annexed at Annexure VIII to the eligible unit of category "A", "B" and "C" within 30 days from the date of the receipt of the application from such units;

- (iii) The Commissioner or the Assistant Commissioner of Taxes/Superintendent of Taxes, as the case may be, shall withhold the issue of Certificate of Entitlement or refuse to grant it, if the application and the documents, accompanying therewith are not found to be in order and the conditions laid down for the purpose are not fulfilled or if any information furnished is not correct.
- (iv) A register of the Certificate of Entitlement so issued shall be maintained in the concerned Office in the format annexed at Annexure-IX of this Scheme.

#### 6. Tax Return:

In accordance with the provisions of the Act and the rules framed thereunder, the eligible unit shall file tax return and annual return within the prescribed time to the jurisdictional Assistant Commissioner of Taxes/Superintendent of Taxes. However, such tax return and annual return shall be in the formats annexed at Annexure-X and XI of this Scheme:

Provided that till Certificate of Entitlement is granted, the unit shall submit tax returns and annual return in Form-13 and Form-14 annexed to the Assam Value Added Tax Rules, 2005 respectively. After receiving the Certificate of Entitlement, the unit shall furnish tax return and annual return in the Formats annexed at Annexure-X and XI of this Scheme.

#### 7. Renewal of Certificate of Entitlement:

The Certificate of Entitlement shall remain valid for a year only, i.e., upto the end of financial year and thereafter shall be renewed by the concerned Assistant Commissioner of Taxes/Superintendent of Taxes, notwithstanding the fact whether the Certificate of Entitlement is issued by the Commissioner of Taxes or the concerned Assistant Commissioner of Taxes/Superintendent of Taxes himself, after examination of annual return for each financial year or for a fraction of financial year till the eligible unit reaches the maximum permissible limit of tax exemption as specified in the para 3 of the Scheme. The concerned Assistant Commissioner of Taxes/Superintendent of Taxes of the area shall examine the returns furnished in the format at Annexure-X and XI by the eligible unit and pass necessary orders as and when the unit reaches the maximum limit of tax exemption, withdrawing the Certificate of Entitlement with intimation to the Commissioner of Taxes and authority granting the Eligibility Certificate besides realizing the due taxes and taking action for violation of provisions, if any, under the provisions of the Assam Value Added Tax Act, 2003.

#### 8. Particulars of Certificate of Entitlement on the invoice:

The holder of the Certificate of Entitlement in the case of an eligible unit shall be competent to sell his finished products in the State of Assam or in the course of inter-State trade or commerce, for which the unit shall be eligible to partial exemption of taxes. In the tax invoice or the retail invoice, as the case may be, issued to the purchaser, the holder of the Certificate of Entitlement, in addition to his tax payer identification number (TIN) shall also clearly mention the number and date of his Certificate of Entitlement.

#### 9. Refund of tax during the pendency of the application of Eligibility Certificate:

- (1) Notwithstanding anything contained in this Scheme, where an eligible unit of has made an application for Eligibility Certificate in accordance with this Scheme and such application has remained pending for disposal, the amount of tax due without claiming exemption shall be paid in accordance with the provisions of the Assam Value Added Tax Act, 2003. The eligible unit can claim refund of tax paid in excess of the actual liability under this Scheme after receipt of the Certificate of Entitlement.
- (2) The application for refund as referred to in clause (1) above shall be made in format in Annexure-XII to the concerned Assistant Commissioner of Taxes/Superintendent of Taxes within one hundred and eighty days from the date of receipt of the Certificate of Entitlement.
- (3) An application for refund shall be signed and verified as in the case of application for Certificate of Entitlement.
- (4) The Assistant Commissioner of Taxes/Superintendent of Taxes may reject, any claim for refund if the claim filed appears to involve any mistake apparent from the record or appears to be incorrect or incomplete, based on any information available on the record, after giving the eligible unit the reasonable opportunity of hearing before such rejection.
- (5) When the Assistant Commissioner of Taxes/Superintendent of Taxes is satisfied that the refund claimed is due he shall record an order sanctioning the refund.
- (6) When the amount to be refunded is more than rupees three lakhs the Assistant Commissioner of Taxes/Superintendent of Taxes shall take prior approval of Deputy Commissioner before sanctioning such refund. The Deputy Commissioner shall not approve the refund if the amount to be refunded exceeds rupees ten lakhs but forward such cases to the Commissioner for approval.
- (7) The other provision of refund under the Assam Value Added Tax Act, 2003 shall apply *mutatis mutandis*.

## 10. Termination of Eligibility Certificate as well as the Certificate of Entitlement for violation of or non-compliance with any of the conditions laid down in the Scheme:

- (1) Under this Scheme, the Eligibility Certificate as well as the Certificate of Entitlement are granted to an unit, which fulfils all eligibility conditions in terms of this Scheme to enable the unit to enjoy the benefit of tax exemption in terms of this Scheme. Violation of any condition of the eligibility or information on any of these conditions being found false at any time after the issue of the Eligibility Certificate or obtaining of such certificate by fraud or misrepresentation or suppression of facts or failure on the part of the holder of the Certificate of Entitlement to comply with any condition or to furnish any information required by the concerned Assistant Commissioner of Taxes/Superintendent of Taxes with regard to the implementation of this Scheme shall entail the termination of both the Eligibility Certificate and Certificate of Entitlement.
- (2) For violation of any condition of eligibility in reference to which the Eligibility Certificate has been granted to an unit as per the provisions of this Scheme or if it is

found at any time after the issue of Eligibility Certificate to an unit that the information furnished by it on any of the conditions, which had led to the issue of the Eligibility Certificate to the unit is false or it is found that the Certificate was obtained by fraud or misrepresentation or suppression of facts, the competent authority which had issued the Eligibility Certificate shall be competent to terminate the same after giving an opportunity of hearing to the holder of the Eligibility Certificate against such termination. In the event of any such termination, the competent authority shall intimate the fact of such termination forthwith to the concerned eligible unit and the Commissioner of Taxes and the concerned Assistant Commissioner of Taxes/Superintendent of Taxes. On receipt of such intimation, the Commissioner of Taxes or the Assistant Commissioner of Taxes/Superintendent of Taxes shall cancel forthwith the Certificate of Entitlement issued to that unit and require such unit to surrender the same forthwith.

(3) For failure on the part of a holder of the Certificate of Entitlement to comply with any condition of eligibility under the Scheme or to furnish any information required by the Assistant Commissioner of Taxes/Superintendent of Taxes with regard to the implementation of this Scheme as per this notification, the Commissioner of Taxes or the Assistant Commissioner of Taxes/Superintendent of Taxes who had issued Certificate of Entitlement shall be competent to terminate the Certificate of Entitlement, after giving an opportunity of hearing to the holder of the Certificate of Entitlement against such termination. In the event of any such termination, the Commissioner of Taxes or the concerned Assistant Commissioner of Taxes/Superintendent of Taxes shall intimate the fact of such termination forthwith to the concerned competent authority who had issued the Eligibility Certificate to this unit. On receipt of such intimation the competent authority shall terminate forthwith the Eligibility Certificate, granted to the unit and communicate the same to the unit as well as the Commissioner of Taxes or the concerned Assistant Commissioner of Taxes/Superintendent of Taxes.

Further, it would not be necessary that Eligibility Certificate is terminated before Certificate of Entitlement is terminated.
